Course Content and Structure:

The course addresses recent examples of the international community's efforts to prevent and manage armed conflicts. The nature of these efforts vary, including for example attempts to initiate negotiations or economic sanctions, but the matter of the use of force (or the threat thereof) to prevent others from the use of force is particularly relevant in situations of military intervention.

The course is devoted to decision-making on international operations at both national and international levels (including decision-making in different international organisations). The course also addresses matters such as the composition, tasks and effectiveness of intervening militaries, as well as ethical dimensions of intervention, including norms of a responsibility to protect and the Westphalian order.

The teaching methods include lectures, individual study and seminars.

Intended Learning Outcomes:

Having finished the course the student will be able to:

- Critically compare different theories of military intervention
- Independently identify different challenges of international peace-support operations
- Examine decision-making on mission mandate, implementation and organisational learning during international peace-support operations

Assessment and Examination:

The course is examined through active and constructive participation in discussions during the mandatory seminars, as well as an individually written assignment.

Absence from a mandatory seminar may, subject to the examining teacher's decision, be compensated by submission of a written supplementary task.

The examining teacher can decide on supplementary tasks in order for the student to achieve a passing grade (G). Late submissions are not accepted, except under certain medical or other compassionate circumstances that the examining teacher has sanctioned beforehand. The student must complete the supplementary task within three working days of its announcement, except under circumstances that the examining teacher has sanctioned beforehand.

Number of examination sessions:

There is no limit of the number of examination sessions.

Grading:

Grading is done according to a three-tiered scale: Pass with distinction (VG), Pass (G), and Fail (U).

In order to achieve a Pass with distinction (VG) on the course, the student has to have participated actively and constructively in the mandatory seminars, and received a Pass with distinction (VG) on the individually written paper.

In order to achieve a Pass (G) on the course, the student has to have participated actively and constructively in the mandatory seminars and received a Pass on the individually written paper.
